The Nehemiah Summit—Part 2 Relational Wisdom 360—Dr Ken Sande

³⁴ So now I am giving you a new commandment: Love each other. Just as I have loved you, you should love each other. ³⁵ Your love for one another will prove to the world that you are my disciples." John 13:34-35

³⁷ Jesus replied, "You must love the LORD your God with all your heart, all your soul, and all your mind. ^{[a] 38} This is the first and greatest commandment. ³⁹ A second is equally important: 'Love your neighbor as yourself. Matthew 22:37–39

Dr Sande addressed the fact that sometimes there is conflict in the church, just as there is in a family. He suggested that conflict arises from unmet desires. And it generally follows this course: 1) I desire; 2) I demand; 3) I judge; 4) I punish.

Dr Sande offered some steps for resolving conflict that I want to share with you all. The first is repentance. He outlined seven—no eight—A's of confession. 1) Address everyone involved; 2) Avoid if, but, or maybe in your confession—that just puts the other person(s) on the defensive; 3) Admit specifically; 4) Acknowledge the hurt; 5) Accept the consequences; 6) Alter your behavior; 7) Ask for forgiveness; 8) Allow time for people to process all of this and offer forgiveness.

He then shared Four Promises of Forgiveness. These are 1) I will not dwell on this incident; 2) I will not bring it up and use it against you; 3) I will not talk to others about this incident; 4) I will not allow this to stand between us of hinder our personal relationship.

Sometimes we just need to PAUSE said Dr Sande.

Prepare—do the research on a given subject and pray over it

Affirm relationships, show respect

Understand interests

Search for creative solutions

Evaluate the options objectively
