To Celebrate or Not to Celebrate

There has been a lot of speculation about whether Christians should celebrate Halloween, and how we should do that if we choose to celebrate. The Bible does not say anything specifically about Halloween since there was no such holiday during the time when Scripture was written by those whom God inspired to write.

There are those who say it is a pagan holiday and that the Church started a tradition to combat the evil holiday we call Halloween. November 1st is, on the church calendar, All Saints Day which was started by the Roman Catholic church. "Hallow" (which means holy person) refers to that day, and "een" refers to the eve of All Saints Day.

Why black and orange? One author that I read says that to the Celtic people in Ireland, black signified the death (or end of) summer; and orange was the color that represented harvest in the fall of the year.

The tradition of wearing costumes started because some folks in Ireland—the Celtics and the Druids, among others—thought the from sundown on the 31st of October until sundown on the next day was a time that people from the other world could visit the earth once again. So, people began wearing costumes so that the spirits would not think they were humans. However, the Roman Catholic Church began suggesting that the costumes reflect the character of the saints—either Biblical or the recognized saints of the church.

The decorations that people put up for Halloween were to ward off evil spirits so that no harm would come to the people living in those houses. Candy or sweets were left outside to appease those spirits also. The practice of trick or treating has is roots in Scotland and Ireland from at least in the 16th century. The people dressed up in costumes would perform for people and then would be treated with food or some kind of treat. In our country, this is a time to have fun, for people to dress up, and is primarily for the children. I remember in the 60s and 70s when people were finding razor blades in apples or needles/straight pins in candy bars that were given out on Halloween and having to take the candy/treats to have them X-rayed to make sure they were safe. This has gotten way out of hand so that people have to be careful where their children go trick or treating. That's why churches and other organizations have started trunk or treat; and why some communities have limited the time for this activity. Some have even changed the date of these activities.

Anton LaVey, founder of the church of Satan, said, "I am glad that Christian parents let their children worship the devil at least one night out of the year. Welcome to Halloween." In other words, according to the church of Satan, participating in Halloween is celebrating Satan and evil.' (Christianity.com). Since we lived in Colorado Springs for five years and had a neighbor who was a priestess in the Satan-worship, I have been very careful about how I view this seemingly harmless day. Our neighbor told us that on Halloween is when Satan worshippers hold their rituals, offer sacrifices (sometimes animals, sometimes humans), and other ceremonies. We were told by our pastor that Ellen was hidden that night every year so that her former "friends" from the cult could not find her. They wanted her dead so that she could not divulge any information about their practices. Also, all the evangelical, Christian churches would pray for rain or snow that night so that it would be hard or even impossible for the Satanists to hold their rituals.

Since the Bible does not say anything about how we celebrate this day, Christians should follow their conscience about how we celebrate Halloween. Use your best sense of how God would want us to celebrate so that we glorify our Lord and stay away from practices that would imply otherwise. When you enter the land the Lord your God is giving you, do not learn to imitate the detestable ways of the nations there. Let no one be found among you who sacrifices their son or daughter in the fire, who practices divination or sorcery, interprets omens, engages in witchcraft, or casts spells, or who is a medium or spiritist or who consults the dead. Anyone who does these things is detestable to the Lord; because of these same detestable practices the Lord your God will drive out those nations before you. You must be blameless before the Lord your God (Deuteronomy 18:9-13). "Through Jesus, therefore, let us continually offer to God a sacrifice of praise—the fruit of lips that openly profess his name" (Hebrews 13:15).
